## **Registration Fees**

**Option #1 - \$350.00 per person - All-Inclusive**. This registration fee includes registration fees, a room at the Yellowstone Alliance camp that sleeps 3 and sometimes more, for Thursday, Friday and Saturday nights and the following meals: supper on Thursday; breakfast, lunch and supper on Friday and Saturday; and breakfast on Sunday morning. This rate assumes that there will be at least two people in the room.

**Option #2 - \$230.00 per person - Commuter 3 day.** This fee is for those who have arranged for their own accommodations offsite for Thursday to Saturday night. This fee includes registration fees, camp use fees and the following meals: supper on Thursday; breakfast, lunch and supper on Friday and Saturday; and breakfast on Sunday morning.

**Option #3 - \$170.00 per person - Commuter 2 day.** This fee is for those who have arranged for their own accommodations offsite for Friday and Saturday nights. This fee includes registration fees, camp use fees and the following meals: breakfast, lunch and supper on Friday and Saturday; and breakfast on Sunday morning.

**Recreational Vehicles**. For a fee of \$150.00 participants can park a recreational vehicle in one of 6 fully serviced spots offered by the camp. *Those staying in the RV must purchase their meals and pay registration and camp fees under Option #2 or Option #3.*
